Very few traffic lights mean periodic U-Turn lanes on *Marcos Highway*, and sometimes an officer in a safety vest stands in an intersection to facilitate flow. 
This blind man seeking alms is led through momentarily stopped cars at one of the few traffic signals at a busy intersection in Manila.


I hope none of my former ABE students would fall for that kind of

In the United States, the unintended pregnancy rate declined 23% between 1990-1994 and 2015-2019. During the same period, the abortion rate declined 48%. The share of unintended pregnancies ending in abortion fell from 50% to 34%.


The Philippine Legacy of Life



Facts:

The case involved Mississippi's Gestational Age Act, passed in 2018, which prohibited abortions after 15 weeks except for medical emergencies or severe fetal abnormalities. The act also applied penalties such as license suspension to abortion providers. Consequently, Jackson Women's Health organization filed suit in a federal district court and challenged the constitutionality of the Gestational Age Act. Thomas Dobbs (the petitioner) was a Mississippi State Health officer. Dobbs filed a petition for certiorari, which was granted. The Supreme Court granted writ to address whether all pre-viability prohibitions on elective abortions are unconstitutional.



Facts on Abortion in the Philippines: Criminalization and a General Ban on Abortion

The Center for Reproductive Rights works nationally and internationally to expand access to reproductive healthcare for women around the world. We have conducted years of investigative research into the status of reproductive rights in the Philippines: The facts are as follows:

- d For over a century, abortion has been criminalized in the Philippines. The criminal provisions on abortion do not contain any exceptions allowing abortion, including to save the life of the pregnant woman or to protect her health. Abortion was criminalized through the Penal Code of 1870 under Spanish colonial rule, and the criminal provisions were incorporated into the Revised Penal Code passed in 1930 under U.S. occupation of the Philippines. The criminalization of abortion has not prevented abortion, but instead has made the procedure unsafe and potentially deadly for the over half a million women each year who try to terminate their pregnancies. In 2008 alone, the Philippines' criminal abortion ban was estimated to result in the deaths of at least 1,000 women and complications for 90,000 more.
- Physicians and midwives who perform abortions in the Philippines with the consent of a pregnant woman may face up to six years in prison under the Revised Penal Code. These criminal punishments are supplemented by separate laws that prescribe sanctions for a range of medical professionals and health workers such as doctors, midwives, and pharmacists for performing abortions or dispensing abortifacients such as the Medical Act, the Midwifery Act, and the Pharmaceutical Act. According to these laws, these practitioners may have their license

- to practice suspended or revoked if caught engaging in abortion-related activities. Women who undergo abortion for any reason may be punished by imprisonment for two to six years.
- Because of the lack of access to safe abortion, Filipino women with lifethreatening pregnancies have no choice but to risk their lives, either through unsafe abortion or through continuation of high-risk pregnancies. Poor women are particularly vulnerable to unsafe abortion and its complications, as they face barriers in obtaining effective means of family planning and lack access to reproductive health services. Common physical complications that arise from the use of such crude and dangerous methods include hemorrhage, sepsis, peritonitis, and trauma to the cervix, vagina, uterus, and abdominal organs.
- The criminal abortion ban has stigmatized the procedure in the medical community, so that women face tremendous barriers and significant abuse when they seek treatment for abortion complications. Filipino women who seek treatment for complications from unsafe abortion have repeatedly reported that the stigma around abortion means that healthcare workers are unwilling to provide care or only treat women after "punishing" women who have undergone abortions by threatening to report them to the police, harassing women verbally and physically, or delaying care. Filipino women who have undergone unsafe abortions for health reasons report that healthcare workers have not been sympathetic to their situation, but instead continue to abuse and threaten them.

The stigma surrounding abortion is perpetuated by the Government of the Philippines' acquiescence to the demands of the Catholic hierarchy, including the Catholic Bishops Conference of the Philippines (CBCP). The strength of the Catholic hierarchy's influence in the Philippines was evident in 1987, when Catholic bishops and leaders succeeded in making the 1987 Constitution the first Philippines constitution ever to recognize a government obligation to protect "the life of the unborn from conception." The Government of the Philippines continues to permit the CBCP to undermine women's health even-today by conceding to its demands to deprive women of a range of reproductive health services, including access to contraception for poor women, comprehensive family planning counseling, and sex education.

As a result of the criminal abortion law and the discriminatory environment in the Philippines, women are left without a means to control their fertility, exposed to unsafe abortions, and made vulnerable to abuse in the health system.

Govt rejects UN proposal to allow divorce, abortion

(UPDATE) THE Philippines has rejected outright the recommendation of the United Nations Human Rights Council (UNHRC) to legalize same-sex marriage, as well as to allow abortion and divorce.

Justice Secretary Jesus Crispin Remulla said such recommendations of other UN member-states during last weekâ??s Universal Periodic Review (UPR) in Geneva are â??not acceptable.â?•

â??Itâ??s a matter of policy whether we accept it or not and I think we know as a country, we are not ready for that,â?• Remulla said in a press briefing on Monday.

â??Culturally, our values may conflict with many of the values that they (Western countries) want to impose upon us. We are not ready for that, culturally we are not ready for that. That is our position right now,â?• he added.

â??Actually, I think we are the only country together with the Vatican that still does not recognize divorce. We just do not recognize it because the premises of that has not been laid out properly. We want the legislature to do their job,â?• Remulla said.

He stressed that the matter on divorce is legislative a??so we cana??t really promise them that.a?•

â??We have to reject it,â?• he said.

Justice Undersecretary Raul Vasquez said the recommendations were rejected outright by the Philippine delegation â??because of national identity, our religious beliefs and our cultural traditions and the Philippine sovereignty that need to be protected and upheld at all times.â?•

The UPR is a peer review mechanism where the promotion and protection of human rights in all 193 UN member states are reviewed on a regular basis.

â??It provides an opportunity for all states to declare what actions they have taken to improve the human rights situations in their countries and to overcome challenges to the enjoyment of human rights,â?• Assistant Secretary Jose Dominic Clavano 4th, Department of Justice (DoJ) spokesman, said.

Out of the 179 UN member-states, 117 participated in this yearâ??s review.

Remulla said more than 100 member states sided with the Philippines or had positive notes â??in the human rights performance of the Philippines.â?•


He said around 15 UN member-states â??remained in the negative.â?•

â??These are the usual countries that always pick on the Philippines. These are the rich countries from Europe that are very, very high on individual rights and have no notion of community rights. But I think we did very well,â?• the Justice chief said.

The Philippine delegation to UPR accepted more than two-thirds of the recommendations put forth by the reviewing countries.
