

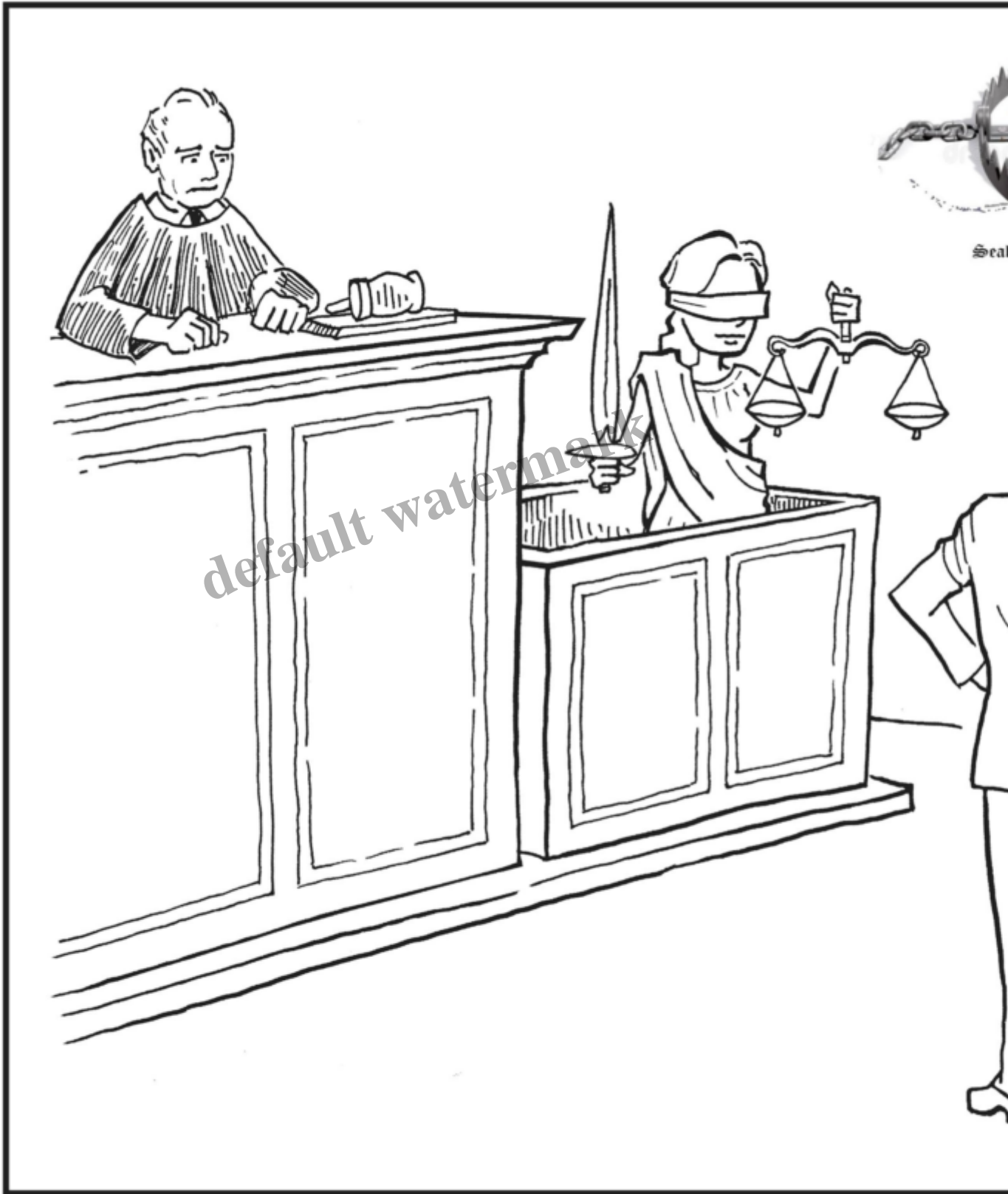

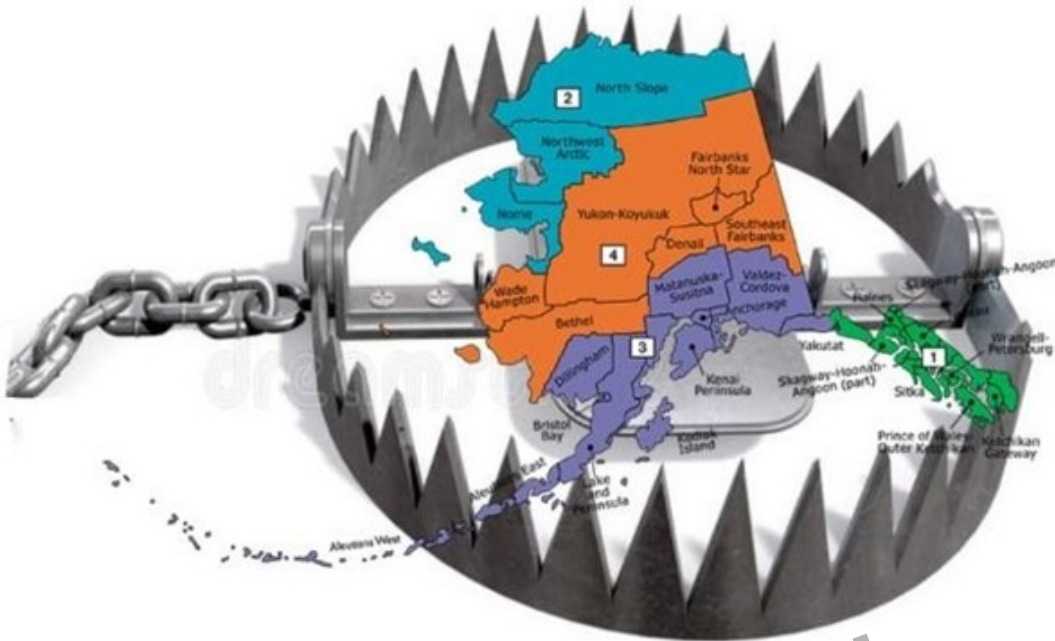

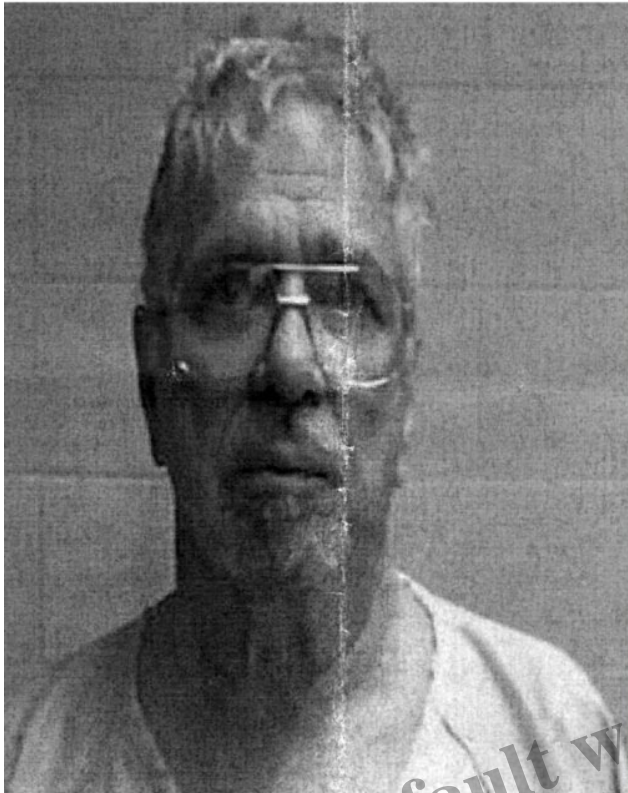

My own last interaction with Judge Washington, in a filing to the court January 29, 2025 may have contributed to her decision to retire.

I hope so.

Whereas, Donn & Waneta were both seniors on fixed incomes enjoying living in the Upper Eagle River home he owned, until public revelation that Defendant had committed fraud in a Palmer real estate transaction in which he publicly professed to sell **Mt McKinley Meats and Sausages, Inc.** slaughterhouse to an Alaskan whom Defendant likely knew was unable to afford it (Todd Elsberry, North Pole Pork Farmer). 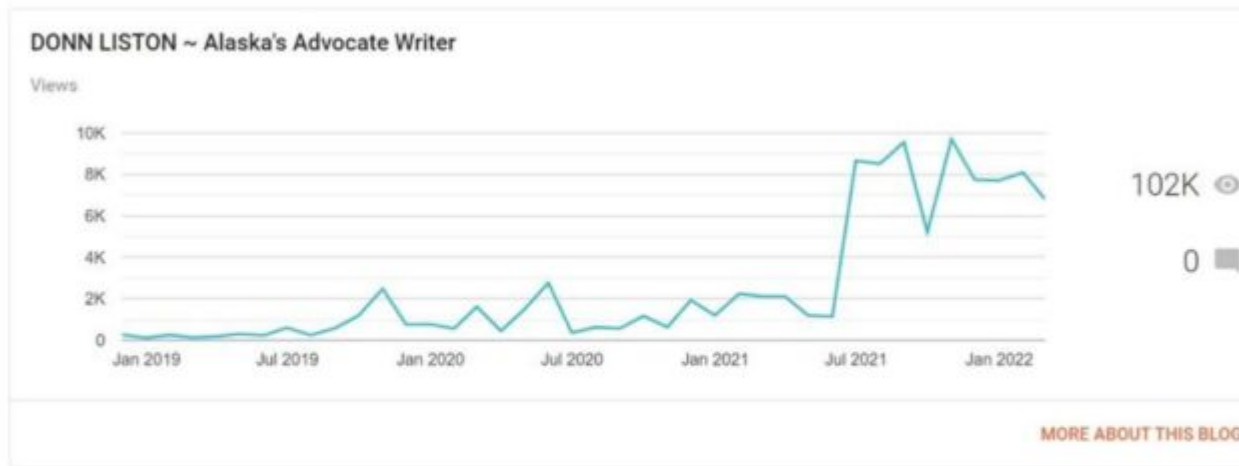



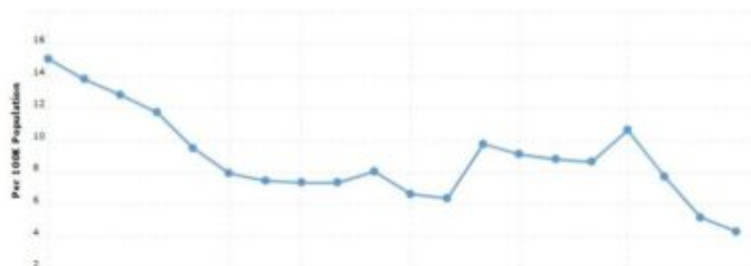

THEREFORE, given the facts above, and the obvious realization Alaska courts neither care nor are willing to protect Alaskans against criminals, Plaintiff seeks an Order for compensation from William Borden, dba High Caliber Realty, Inc.
