Bill Borden and **Greg Giannulis** were in high spirits after announcement in November 2021 that the only **USDA-Certified** slaughterhouse in Southcentral Alaska had been sold. Spirits changed when Giannulis learned Borden had cut himself a 14% interest in the company making the purchase offer, without revealing this personal interest to Giannulis. Borden arranged LEASE of the former State

money pit to an Alaskan farmer, but today it still belongs to Gianullis--lock, stock, and barrel.

Upon purchase of the plant from the **State of Alaska** for cash in 2017 Giannulis removed all state-subsidized **Department of Corrections** workers and inmates. As one of Alaska's premiere businessmen, Giannulis invested in upgrading the facility and complied emphatically with all laws, regulations and government requirements in a quest to build a commercial agriculture base for in-state red meat production.

The next annual lease payment for this plant is about to come due in early November and Alaska Meat Packers recently announced it will no longer be accepting animals for processing.

Who hasn't heard of a real estate huckster finding a way to sell a property, knowing the purchaser cannot afford it, hoping to pick up that property on the bounce for pennies on the dollar?

It happens!

The Setup



Earlier in 2021 **Greg Giannulis** showed the various parcels of land worth an estimated \$3.5 Million available as listings for **Bill Borden** (with pig tail) and **High Caliber Realty, Inc.** (sic) Alaska Manager **Ken Peltier**, in the conference room of **Mike's Quality Meats**.

Borden publicly professed to sell the **Mt McKinley Meats & Sausages** Palmer slaughterhouse in a ceremony with Gov. **Mike Dunleavy** in attendance, including a lot of associated hoopla by the **Alaska Farm Bureau**.

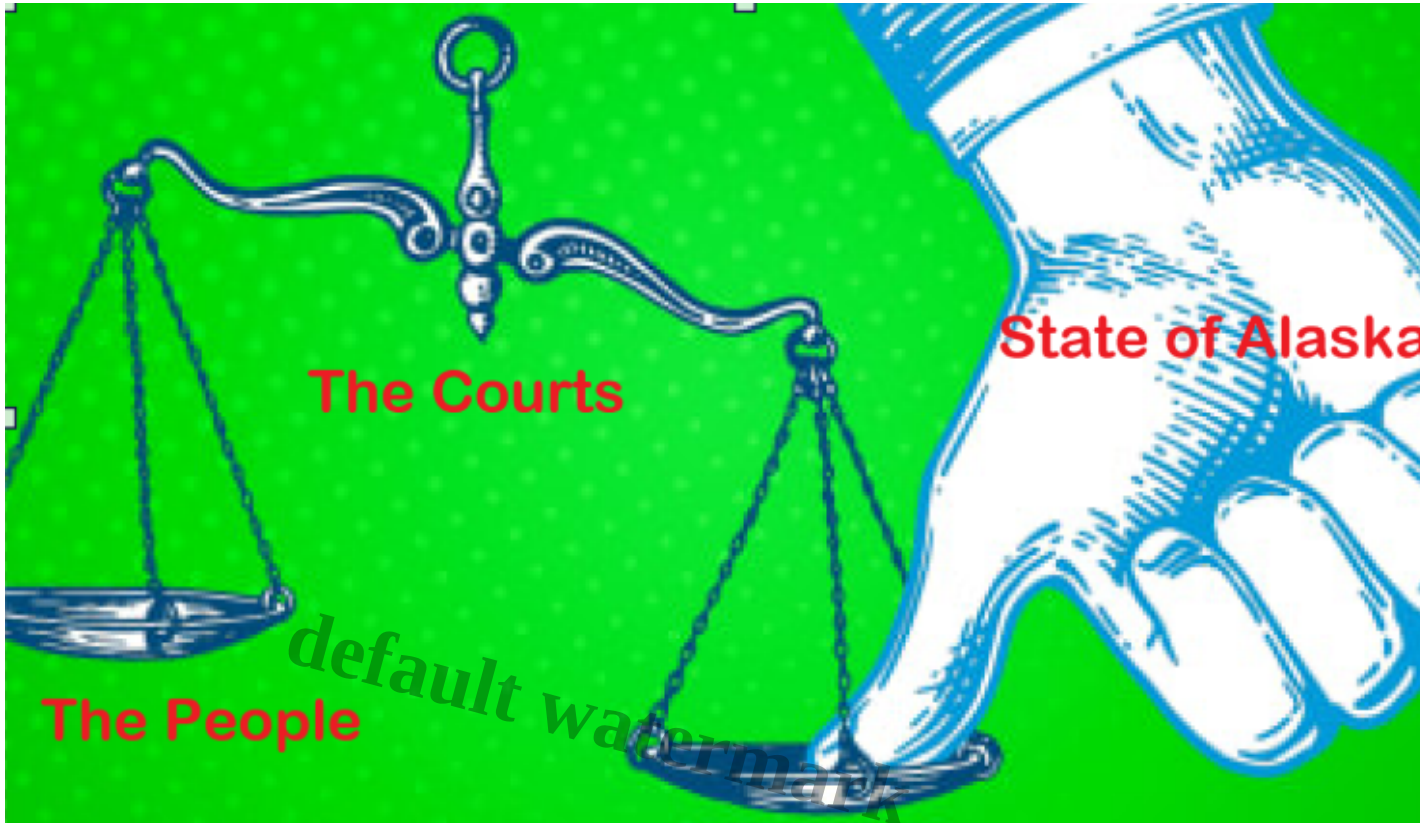

Are Alaskans Being Set up to Fail?

Watch now for Alaskans of goodwill, under the banner of *Food Security* to ask Gov. Dunleavy and the **AK Legislature** to use **State of Alaska** resources to bail out Borden's scam. This is much easier than dealing with the no-nonsense approach to successfully producing meat for Alaska consumers without Task Force group-gropes. Under pressure to DO SOMETHING, expect elected officials to create another money pit for hobby farmers as was previously run by **Division of Agriculture Central Committee**. In private ownership THIS FACILITY made a profit four years, with a capacity of 300-750 animals per week, without state subsidies. Before the pandemic Giannulis reduced costs of some meats for Alaskan consumers below Seattle prices.

FOOD INSECURITY:

Alaska Food Prices and Availability are Controlled by Seattle



This writer witnessed **Greg Giannulis** climbing the sides of the truck he owns that had just arrived at Giannulis's ***Rocket Ranch*** with some 40 beefs from Delta. To approach minimal AK Food Security would require commercial agriculture operations handling dozens of trucks like this making delivery to processing plants every week—as currently occurs all across Northern Canada. Instead AK Consumers send \$2-4 Billion/year to Seattle for meat.

Early in 2021 Giannulis had appealed to elected officials in Juneau at the beginning of session with this letter asking them to start addressing public policies required to make commercial agriculture viable in Alaska. The state is unable to grow enough livestock for food security because of ag land policy which limits business viability.

This request was mostly ignored and nothing has changed.

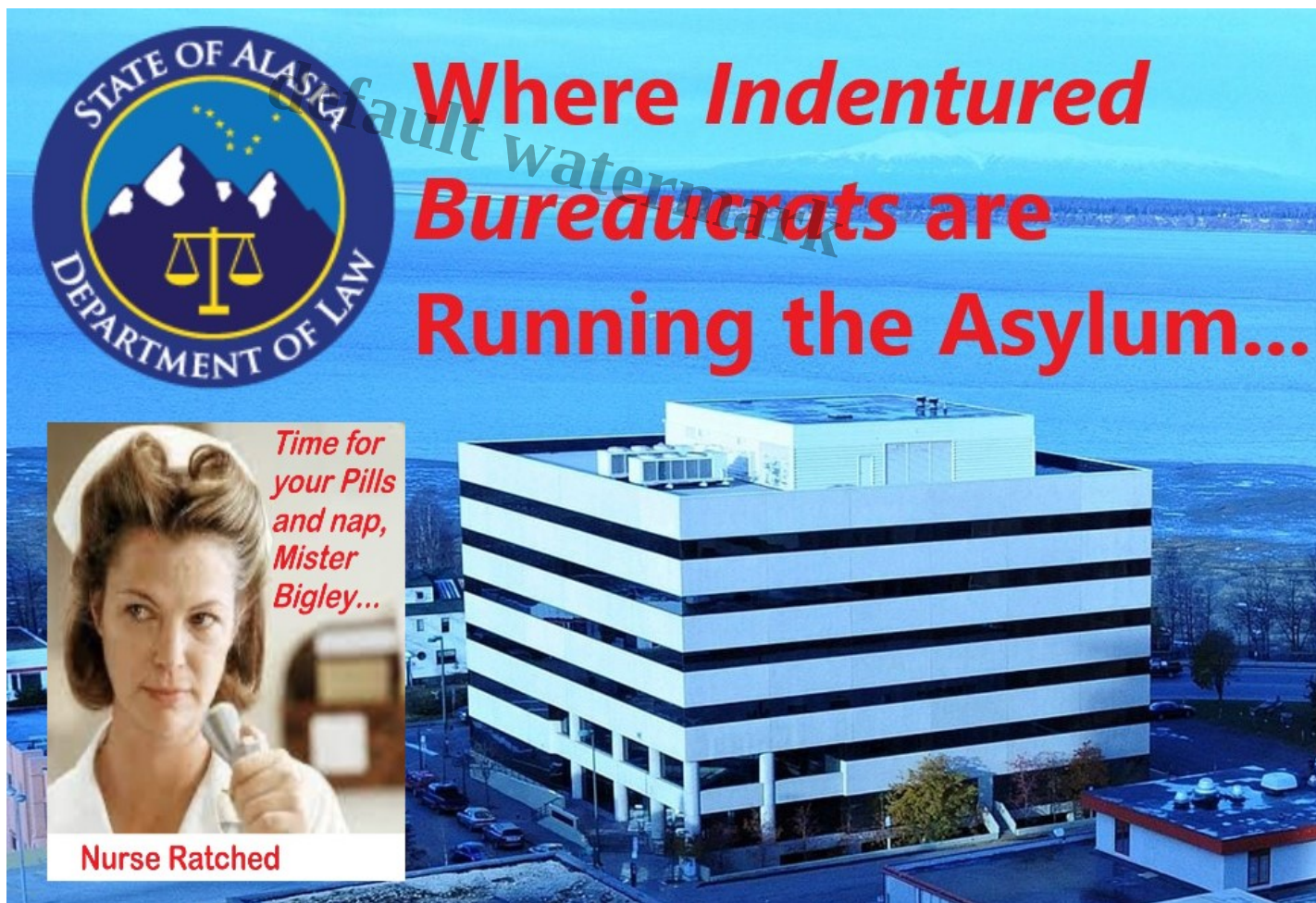

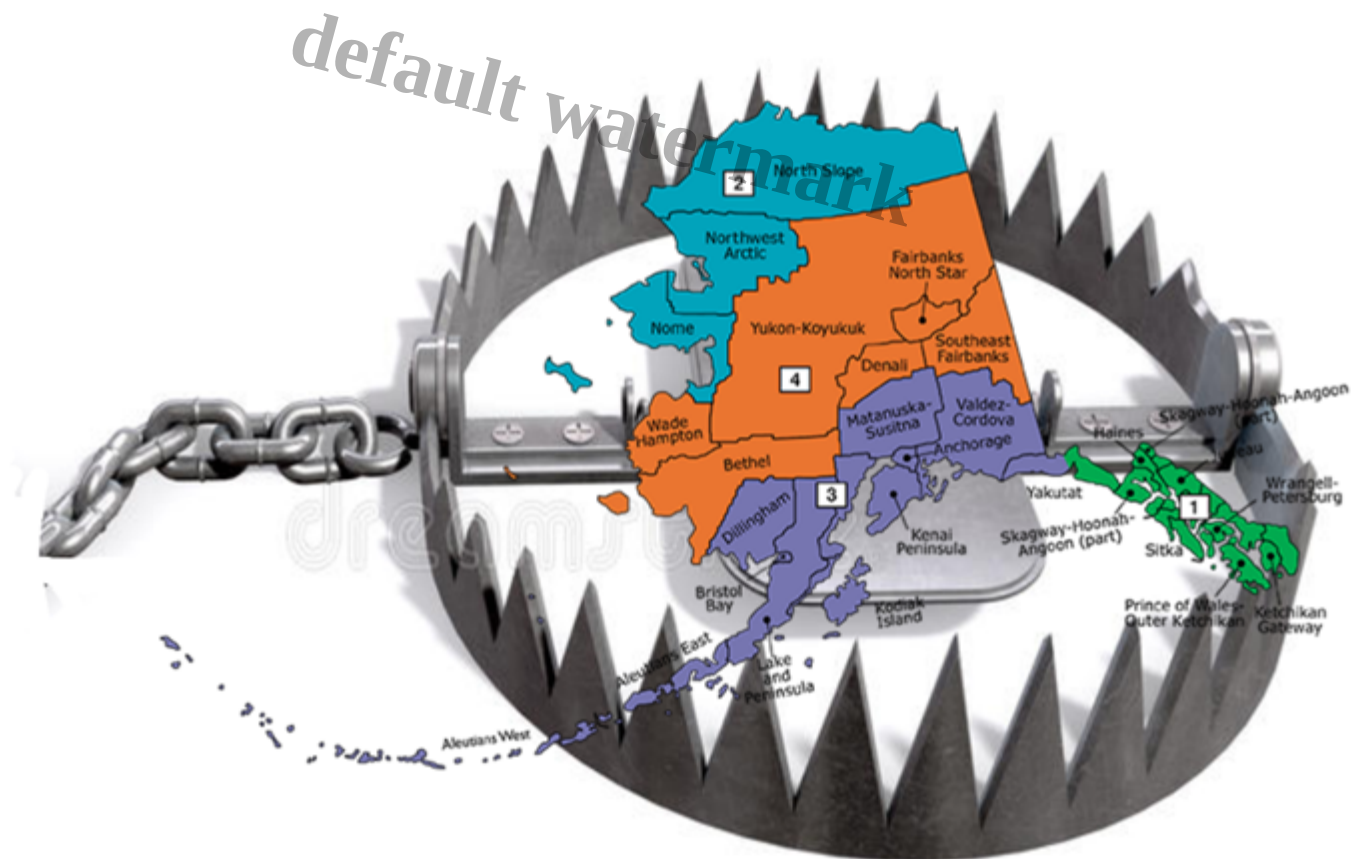

Alaska judges are **State Employees**, retained after that very special political appointment under what is known as the **Missouri Plan** according to a specific schedule requiring all to first stand for election after more than three years service. After that the schedule for standing for retention is varied by court.

Alaska Supreme Court appointees stand for retention election every 10 years after their first election. Two **AK Supreme Court** judges are up for retention in the current election: 1) **Dario Borghese** was first appointed in July 2020 and this retention election will be after more than four years, 2) **Jennifer Stuart Henderson** was appointed July 2021 and her first Retention Election this year comes after more than three years. If these two judges are retained in this election they will each serve 10 years before having to run again for retention.



This writer has been critical of the **Alaska Supreme Court**, three (soon 4) members of whom have been appointed by Gov. Dunleavy from a list provided by members of the **Alaska Bar Association** cartel. This requirement is designated by the **Alaska Constitution**. This court has been selective in what parts of the **AK Constitution** it will adhere to, in a system dedicated to protecting judges from meaningful accountability—?even given wrongdoing found by an **AK Grand Jury**.

RELEASE THE KENAI GRAND JURY REPORT ON JUDGE MARGARET MURPHY!

This court has actively circumvented certain provisions of the **AK Constitution** with **SCO 1993**, neutralizing direct appeal for public official misconduct to the **AK Grand Jury**.

Result is a state hamstrung by unaccountable bureaucrats mostly on their Alaska Adventures.

Section 8. Grand Jury

No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a grand jury, except in cases of the armed forces in time of war or public danger. Indictment may be returned against the accused. In that case the prosecution shall be by information. A grand jury shall consist of at least twelve citizens, a majority of whom come from the county where the crime was committed. The power of grand juries to investigate and make recommendations concerning the public welfare or safety shall not be suspended.

Alaska Court of Appeals appointees serve eight years after their first retention election. 1) **Marjorie K. Allard** was first appointed November 2012, her first retention election was 2016. This election will give her eight more years. 2) **Timothy W. Terrell** was first appointed December 2020 and this will be his first retention election after more than three years service.

Superior Court Judges are up for retention election every six years after the initial three. 1) **Rachel L. Ahrens** was appointed in December 2019 and this will be her first retention election after almost five years. 2) **Bride Siefert** also was appointed in December 2019 and hasn't stood for retention in almost five years. 3) **Herman G. Walker, Jr.** was first appointed in July 2015 and had his first retention election in 2018 after three years and stands for retention again after six years in 2024. 4) **Adolf V. Zeman**, was appointed April 2020 and stands for retention for the first time in 2024.

District Court Judges must stand for retention every four years after the initial three. The chart below details the various judges standing for retention including District judges.

After many months of waiting for a decision following a 2-1/2 hour hearing, Judge **Pamela Washington** issued this order and refused to enforce it. 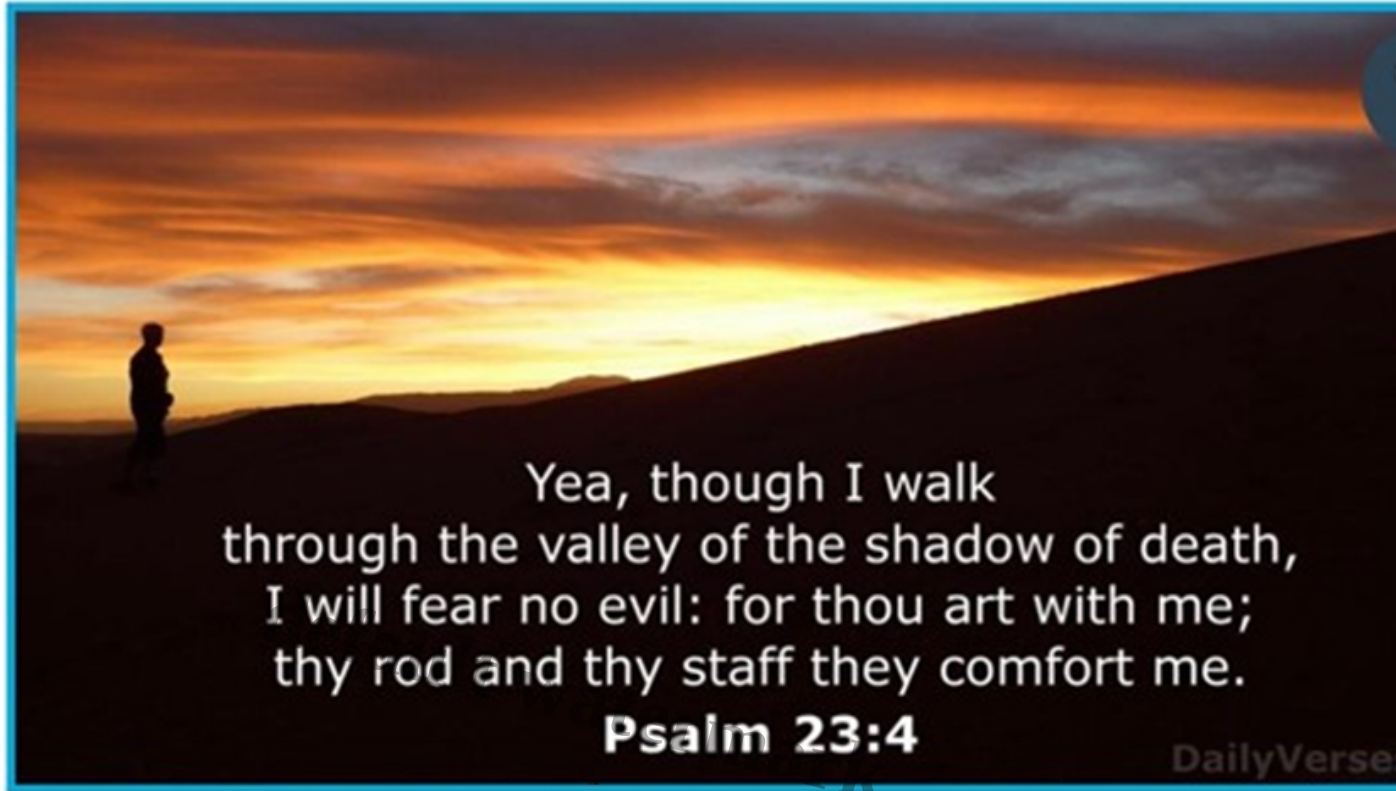

Mr. Liston,

I am responding to your September 6, 2022 public records request for:

"Please provide any agreements or other support for utilizing Department of Corrections inmates to work at the private enterprise Alaska Meatpackers, Inc. processing plant as enabled by DNR. A post on Facebook in March declared that Department of Corrections inmates were working there. I respectfully request all information about how much said inmates' employment there cost the State of Alaska in personnel, transportation or other costs."

The agreement between Alaska Meat Packers and the Alaska Department of Corrections (Point Mackenzie Correctional Farm, PMCF) is attached. Per the agreement, PMCF provides transportation to and from the meat packing plant; PMCF covers the cost for electronic monitoring; and Alaska Meat Packers pays all wages.

- Four hours of transport time for an officer per day. The meat packing plant is located an hour away from the facility; two hours roundtrip in the morning to drop the inmates off; two hours roundtrip in the afternoon to pick them up and return to the facility.
- Average wage per hour for the officers providing the transport to and from the facility to the plant, \$37.51; \$150.04 per day.
- Electronic monitoring costs, \$4.10 per day.
- 68 travel miles per day, \$5.00 per gallon, at 8 mpg is \$42.50 per day.

There are currently two inmates working at the meat plant, an average of three days per week.

Regarding the photo you referenced on the Alaska Meat Packers Facebook page, which showed three inmates, it is the policy of Alaska DOC that still photos of offenders are prohibited if the offender is identifiable. If the photo to which you refer is one of DOC inmates, I will address the issue with the Alaska Meat Packers, and I thank you for making me aware.

Dear Employer,

On behalf of the Alaska Department of Corrections (DOC) and the above named institution, I want to thank you for your interest in providing our offenders with a meaningful employment opportunity as part of our Work Release Program (WRP). It is our sincere belief that by providing certain offenders with the chance to participate in productive work we help them re-integrate back in to the community. These offenders start to connect with community resources while also becoming self-sufficient and gaining a sense of independence. Ultimately this helps them in their transition back in to community life after they are released from the institution.

As an employment partner in our Work Release Program / Vocational Work Release Program, we ask that you adhere to the following guidelines in order to help make the program a success:

- 1.) You must pay our offenders at least minimum wage.
- 2.) Offenders must be paid by regular payroll check, no cash and no commission.
- 3.) Offenders may not accept end of contract payments, where payment is made upon completion of a contract.
- 4.) Offenders may not work as day laborers, where payment is made at the end of the day.
- 5.) You must provide Worker's Compensation coverage, per State and Federal law, for any of our offenders employed at your work site.
- 6.) You must provide insurance covering our offenders work.

In addition, all of our offenders must be trained on the proper use and operation of any tools, equipment, machinery or chemicals in compliance with federal, state and local law. If dealing with chemicals material safety data sheets must also be made available to all offenders.

Please also ensure that all offenders are trained and / or shown what to do in the event of a life safety incident. Training and information should include medical emergencies and first aid, fire alarms and suppression, evacuations routes, chemical spills, etc.

If any of the following behavior should occur, please notify our Work Release Program Officers, your Work Release Program Contact (identified below), or our institution immediately:

- 1.) The offender does not report to work as scheduled.
- 2.) The offender is late for work or is released from work prior to his / her normal quitting time.
- 3.) The offender is terminated from his / her job.
- 4.) The offender's work hours are modified (work crews w/ regular hours).
- 5.) The offender leaves his / her place of employment, or is unaccounted for, during the workday.
- 6.) The offender consumes, or is suspected of consuming, any alcohol or drugs during the workday.
- 7.) The offender is considered for any special operations such as; forklift / crane operator.
- 8.) The offender commits any violations of employee conduct or commits a crime.
- 9.) Any other unusual circumstances that may occur.

- 10.) The offender has a medical issue requiring attention.
11.) The offender has a major medical emergency and / or is being transported for medical care.

Our Work Release Program Officers may make random checks in person or with a drive-by scanner order to confirm that our offenders are present at your work site. Work release offenders are subject to search and / or apprehension at any time they are away from the institution.

Lastly our institutional staff will be happy to provide you with a brochure and a review of the federal Prison Rape Elimination Act (PREA), as this law is applicable to our offenders even in your workplace.

We appreciate your willingness to comply with the guidelines and to report any of the identified behavior above. It is only with your support that programs such as this can exist and be a success. Thank you.

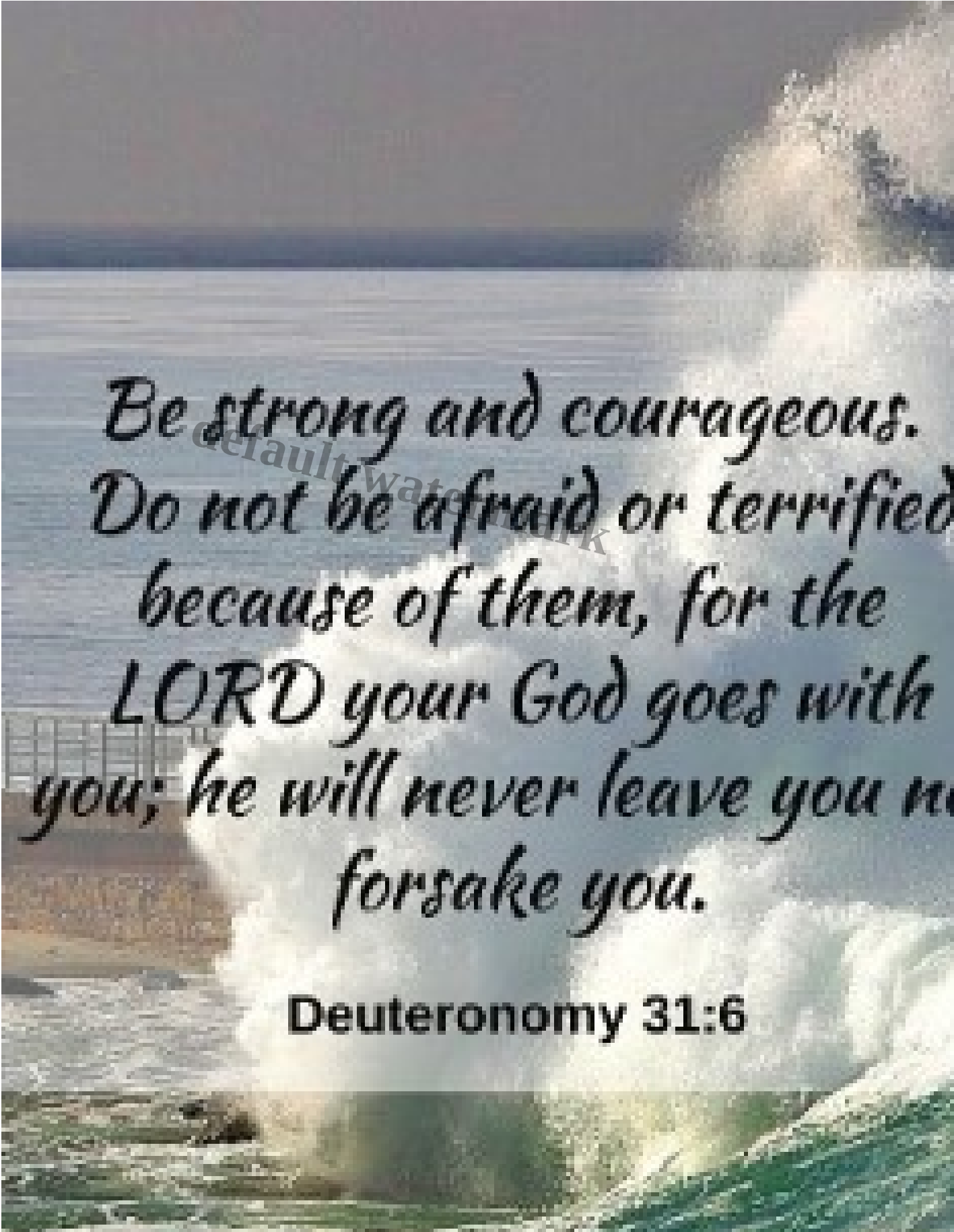
